Although moderately toxic in large amounts, sulfites can pose risk to some asthmatics producing central nervous system depression, broncho constriction and anaphylaxis. EYE CONTACT: May cause irritation, redness, pain, and tearing. SKIN CONTACT: May cause slight irritation. CHRONIC EFFECTS / CARCINOGENICITY: Chronic exposure may affect thyroid, heart, lungs and kidneys due to Cobalt.

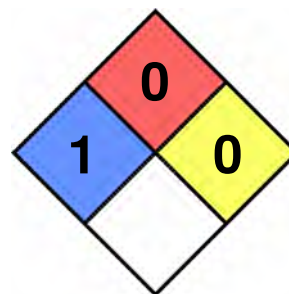
